Subject: Grievance Regarding Outrageous Retribution, Discrimination, and Misconduct by the Principal Mr. Dnyaneshwar R Mohrir, AECS-Turamdih and Mr Saroj Dalai (TGT) towards a PWD staff member with benchmark disability (65%) (Myself,the petitioner)

Respected Sir,

I, M. Senthilnathan, TGT (Art) at AECS-Turamdih, humbly bring to your attention the continuous instances of humiliation, discrimination, and unprofessional behavior perpetrated by 'Mr. Dnyaneshwar R Mohrir', Principal of AECS-Turamdih, and certain staff members under his protection.

Additional Concerns:

1. Neglect of Duties Assigned to Me as an Art Teacher:

Despite being a dedicated art teacher with over 14 years of experience in AEES, Mr Dnyaneshwar Mr. Dnyaneshwar R Mohrir (Principal) has consistently avoided assigning me duties comparable to other staff members. This calculated neglect reflects his ulterior motive to sabotage my Annual Performance Appraisal Report (APAR) and Performance-Related Incentive Scheme (PRIS), which would affect my professional growth and financial well-being.

2. Continuous Dedication despite Humiliation:In spite of these efforts to demoralize me, I have been diligently performing my assigned duties with unwavering commitment. However, the repeated instances of humiliation and insults have deeply affected my morale and sense of belonging within the institution.

3. Incidents of Humiliation and Threats by Other Staff:

I have faced multiple incidents of humiliation, intimidation, and even threats by staff members, including:

- Mr. Rajesh Kr Bhatt (PHE-Request Transferred to Mumbai)
- Mr. Sunil Kanti Chakma (Vice-Principal, AECS-Turamdih)
- Mr. Saroj Dalai (TGT-Science)
- Mrs. Vijayamani (PRT) & Mrs Veena Pradeep (Headmistress)
- Mrs Rupinder kaur(PRT)

4. Favouritism Undermining Institutional Integrity:

The favouritism shown by Mr Dnyaneshwar R Mohrir undermines the very values that AEES promotes, such as vigilance awareness, communal harmony, and institutional integrity. These values, intended to uphold ethical standards and fairness, are reduced to mere symbolic gestures when the Principal himself engages in unethical practices.

Chronology of Incidents:

1. Incident of 12th October 2022:

While I was discharging my duties during the All India Inter-AEES Art Competition, Mr Saroj Dalai, TGT (Science), obstructed my work and humiliated me in public. Despite raising a formal grievance about this incident, the Principal failed to take any action, showing a blatant disregard for my concerns.

2. Incident of 29th April 2023 and 23rd June 2023:

On these occasions, Mr Rajesh Kr. Bhatt, PHE Teacher, threatened me with harm outside the school premises. I submitted grievances regarding these incidents, but the Principal dismissed them lightly, claiming there was "nothing to worry about." His lack of seriousness enabled the offender to continue his threatening behaviour.

3. Incident of 21st November 2024 (Morning):

Around 10:45 AM, while I was assisting students from Classes X-B and X-C with their science project in the physics lab, Mr Saroj Dalai barged in and began shouting in an erratic and threatening manner, asking the students to leave despite my presence as their supervising teacher. His behavior was humiliating, unprofessional, and unwarranted, but the Principal failed to act despite being informed.

4. Incident of 21st November 2024 (Brunch Break):

During the brunch break, Mr. Saroj Dalai deliberately collided with me in an unruly manner in the corridor and threatened me in Hindi, saying, *"If you come across me again,

I will beat you up."* Despite my oral complaint to the Vice-Principal and Principal, no corrective measures were taken, indicating the Principal's indifference to my safety and dignity as a PWD staff member.

5. Ongoing False Allegations by Mr Dnyaneshwar R Mohrir (Principal):

It has come to my attention that the Principal has been influencing higher authorities with false allegations against me, aiming to tarnish my reputation and create grounds for my dismissal. His actions not only reflect personal grudge and vengeance but also intent to sabotage my career and integrity.

Repeated grievances highlighting these incidents have been submitted, but no action has been taken. For instance:

- Mr. Rajesh Kr Bhatt has previously issued intimidation threats, including threatening to kill me (grievances submitted on 29/04/2023 and 23/06/2023).

- Mr. Saroj Dalai has displayed erratic and threatening behavior on multiple occasions.

Despite my efforts to address these incidents formally, they have been ignored, as the individuals involved are perceived as "favourites of the Principal".

Urgent Request for Action:

1. Investigate the Grievances:

I request an impartial investigation into the grievances I have submitted regarding the actions of Mr. Mohrir and other staff members.

2. Demote the Principal:

Given Mr. Mohrir's repeated instances of mental harassment, favoritism, and discriminatory behavior, I urge you to **demote him from his current position until his retirement**. His actions are not conducive to a healthy and inclusive school environment and are detrimental to the students, staff, and the institution as a whole.

3. Prevent Further Malice:

Ensure that Principals and other authorities in AEES are prevented from filing false allegations and engaging in acts of mental torture against staff members. Such behavior tarnishes the institution's reputation and creates a toxic workplace environment.

I remain committed to serving AECS-Turamdih and its students with dedication and sincerity. However, I seek your kind intervention to restore fairness and integrity within the institution and to protect my rights and dignity as an employee and a PWD belonging to a Scheduled Caste.

I sincerely request your intervention to uphold morale, protect my mental health, and restore a professionally healthy environment at AECS-Turamdih, Jharkhand.

In conclusion:

I earnestly request the National Human Rights and Crime Control Bureau to take swift and impartial action against Mr. Mohrir and Ms. Dalai Saroj for their alleged misconduct, which has caused undue distress and humiliation. Teaching is one of the noblest professions, entrusted with shaping the future of society through knowledge, compassion, and integrity. However, such misconduct by authorities and staff tarnishes the image of this esteemed profession and creates a hostile environment that is contrary to the values of inclusiveness and mutual respect.

As a Person with Disability (PWD), I believe in the fundamental right to dignity and fair treatment, which should never be compromised under any circumstances. The actions of the aforementioned individuals appear to reflect a disregard for the rule of law and an oppressive mindset that undermines the principles of equality and justice. I implore the Bureau to conduct a thorough investigation into this matter, ensuring that the truth is brought to light and appropriate measures are taken to hold the perpetrators accountable and uprooted immediately to uphold the integrity of the teaching community and ensure a supportive, fair, and equitable working environment. Let this serve as a precedent that no one is above the law and that all individuals, irrespective of their abilities, deserve dignity, respect, and protection within the system. Subject: Grievance regarding repeated humiliation and mental torture

Dear Sir,

I hope this letter finds you in good health and high spirits. I am writing to bring to your attention a distressing series of incidents that occurred at AECS-TURAMDIH on 19th April 2024, involving the Vice Principal and Mr. Saroj Dalai (TGT). I have been subjected to repeated humiliation and mental torture, which has deeply affected my well-being and peace of mind. I kindly request your intervention in this matter to address the issue and ensure my rights and dignity are upheld.

- 1. On the aforementioned date, at approximately 7:40 AM, I approached the 'Arrangement Period Committee,' consisting of Mr. Sunil Chakma, Mr. Murmu, and Mr. Saroj Dalai, to discuss my discomfort related to my disability. I suffer from osteoarthritis, specifically TIBIO FIBULAR SYNOSTOSIS, which has fused the bones of my tibia and fibula together in the operated area. Additionally, I have signs of arthritis in my locomotory organs. I provided a medical summary, along with a prescription dated 10th March 2024 from Dr. Jayant Kumar, an orthopaedic specialist at Tata Main Hospital, Bistupur, and Jamshedpur, to support my condition (attached for your reference).**

2. To my utmost dismay, instead of receiving understanding and support, I was met with severe humiliation and mental torture from the Vice Principal and Mr. Saroj Dalai. Mr. Chakma sarcastically commented, "students are climbing two-story buildings, why not you?" when I attempted to explain my disability and the challenges I face in climbing steep staircases. This derogatory expression is not only condemnable but also inhumane. Mr. Chakma further dismissed my concerns by stating that I was talking nonsense, displaying a lack of empathy and exhibiting symptoms of 'intermittent explosive disorder' in his impulsive outburst.
3. Furthermore, on 2nd March 2024(Attached email copy sent to I was forcefully stopped and subjected to a frisk by the security guard at the school gate. This act was orchestrated by Mr. Sunil Chakma, the acting Principal at the time, with the clear intention of demoralizing and sabotaging my image in front of other staff members. As a person with a benchmark disability, this incident deeply humiliated and offended me. Mr. Chakma's constant indulgence in retaliatory actions and abuse of power as a reporting officer is highly condemnable and unbecoming of a teacher or an authority figure.
4. Moreover, when I approached Mr. Murmu and Mr. Saroj Dalai before engaging in a conversation with Mr. Chakma on 19th April 2024, Mr. Saroj Dalai argumentatively pointed out that I should have refused to sign the register for the arrangement classes on the upper floor. His unintelligible reasoning and lack of accountability for his mistakes, despite my repeated request letters highlighting my difficulties in climbing staircases due to my disability and the progressive nature of my arthritic condition, demonstrate his indifference and disregard for my well-being.
5. I would also like to bring to your attention an incident dated 12th October 2022, where Mr. Saroj Dalai obstructed my duty by switching off the computer, printer, light, and fan and also asked to 'Get Out' from the exam department as if it's his private property. His impulsive act humiliated and mentally stressed me throughout the day, causing a delay in the completion of my duties. Despite the Principal's intervention, Mr. Dalai escaped any consequences or disciplinary action. It is disheartening to

witness his repeated instances of making fun of me indirectly, believing that he is beyond the reach of the law and immune to punishment.

I believe that every individual, irrespective of their physical condition, deserves to be treated with dignity, respect, and empathy. It is disheartening to experience such mistreatment within an educational institution, which should foster a nurturing and inclusive environment for all students and staff members. I strongly urge you to conduct a thorough investigation into these incidents and take appropriate disciplinary measures against those responsible.

Additionally, I kindly request that necessary accommodations be made to ensure my safe and convenient access to the 7th and 8th class rooms. This may involve providing alternative routes, or ground floor arrangement, to facilitate my movement. Such accommodations are in line with the principles of inclusivity and equal opportunities that should be upheld by the institution.

I trust that you will address this grievance promptly and ensure that necessary steps are taken to prevent the recurrence of such incidents in the future. I look forward to a swift resolution to this matter and your assurance that my rights and well-being will be protected.

I cannot tolerate this behavior.

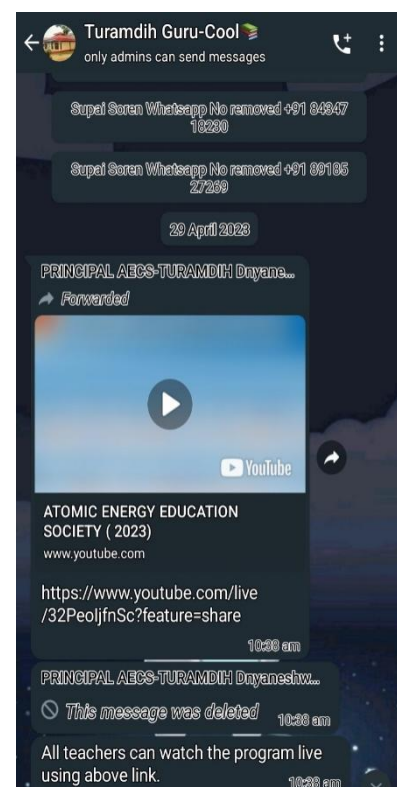

On 29/04/2023 both the Principal and the Vice-Principle were out of station officially, the same day around Mid-Noon around 12 50 P.M to 1: 15P.M,while I was watching the program - 'Education for Holistic Development and Discovering new paradigms in Education', Live on screen, inside the computer Lab, as we were instructed by the Principal sir, to access for the same (WhatsApp message dated 29/04/2023,sent by Mr. Principal, has been attached),Mr. Rajesh Kumar Bhatt, PET(TGT),misbehaved and intimidated me by threatening , that he may 'Kill me outside the school premise ' of AECS,Turamdih. This is outrageous and unbecoming of a teacher. I'm a disabled person (PWD) with (65%) benchmark disability and a staff of AEES (DAE).



As the IPC Law says:



Section 506 of the IPC deals with criminal intimidation, which is defined as the act of threatening someone with injury to their person, property, or reputation with the intention of causing them to do any act which they are not legally bound to do or to omit any act which they are legally entitled to do. The punishment for a conviction under this section is imprisonment for a term which may extend to two years or with fine or both.

Sir, I want justice and the miscreant should be punished, and he should not think that he is above the law. I have already given a grievance letter against Mr. Rajesh Bhatt, but action was not taken yet, and this escalated his misbehavior with his co-staffs and make him feel upper hand over the Authorities and encourages to do more unlawful activities (Not only me but also other staffs might have witnessed him giving corporal punishment several times during the assembly hours, but either the earlier principal Mr. Santhosh Jadav or the current Principal Mr. Dnyaneshwar Mohrir has taken disciplinary action against him.)

Just that he (Mr. Rajesh Bhatt) got transferred from Turamdih to Mumbai, does not mean he can indulge in any kind of crime and easily escapes from his action, it's simply an act of ignorance. The next day, when Mr. Principal came on 30th of April 2023, principal asked me to ignore and not to give a grievance letter. And you are my last resort.

Subject: Grievance Regarding Discrepancy and Deliberate Avoidance of Responsibilities by the Principal, AECS-Turamdih

Respected Sir/Madam,

I hope this letter finds you in good health. I am writing to formally submit a grievance regarding the deliberate avoidance of assigning deserved responsibilities and the continuous efforts to humiliate and undermine my position by Mr. Principal, AECS-Turamdih. Despite my 14 years of dedicated service to AEES and my commitment to fulfilling my responsibilities as an Art teacher and Art In-Charge (I/C), I have been consistently side-lined in favour of individuals less qualified for art-related duties. This has not only impacted my professional standing but has also caused significant personal stress and adversely affected the morale and performance of my students.

Incident I:

During the *Pariksha Pe Charcha 2024* event held on 23rd January 2024, I was completely ignored for the responsibilities related to my role, despite being available and always diligent in my service. Instead, the I/C duty for the event was assigned to Mr. Tandi, a Mathematics teacher with no formal background or

training in art. It is baffling that a teacher with no experience in the subject could be selected over me, an Art teacher with over a decade of experience in this society. This act was not based on professional merit but was a result of personal differences between Mr. Principal and myself. This kind of bias is not only professionally unethical but also a disservice to the students who deserve guidance from a qualified art educator.

Incident II:

The *All India Inter AECS Art Competition and Exhibition 2024-25*, scheduled for 22nd October 2024, further exemplifies the bias and deliberate humiliation I face. Despite having always been involved in discussions and preparations for this event in the past, this year, the I/C duties were once again handed to Mr. Tandi. This assignment to a teacher irrelevant to the subject of Art is not only illogical but also unfair. How can someone with no understanding or passion for the subject be expected to inspire and guide students to perform well in an art competition? Mr. Principal's ignorance and personal vendetta are creating a hostile work environment, and it is alarming that this behaviour has gone unnoticed by the AEES administration.

In anticipation of potential excuses regarding my availability, I would like to clarify that while I was initially scheduled to travel on 19th October 2024, I had to cancel my travel plans due to unforeseen weather conditions. I returned on 20th October 2024, a Sunday, and was always available through email, WhatsApp, or phone. Mr. Principal could have reached out to me through these channels, as he often does with other teachers, but chose not to, further proving his intention to exclude and humiliate me.

Additional Incidents:

For example, he locked the computer room while I was trying to use the projector for my class, citing a baseless concern that students might steal or damage the equipment. I request you to kindly consider my grievance and take the necessary actions to ensure that I am treated fairly and given the responsibilities I deserve as an Art teacher and Art I/C. 5. Ongoing False Allegations by Mr Dnyaneshwar R Mohrir (Principal):

It has come to my attention that the Principal has been influencing higher authorities with false allegations against me, aiming to tarnish my reputation and create grounds for my dismissal. His actions not only reflect personal grudge and vengeance but also intent to sabotage my career and integrity.

Repeated grievances highlighting these incidents have been submitted, but no action has been taken. For instance:

- Mr. Rajesh Kr Bhatt has previously issued intimidation threats, including threatening to kill me (grievances submitted on 29/04/2023 and 23/06/2023).
- Mr. Saroj Dalai has displayed erratic and threatening behavior on multiple occasions.

Despite my efforts to address these incidents formally, they have been ignored, as the individuals involved are perceived as "favourites of the Principal".

Urgent Request for Action:

1. Investigate the Grievances:

I request an impartial investigation into the grievances I have submitted regarding the actions of Mr. Mohrir and other staff members.

2. Demote the Principal:

Given Mr. Mohrir's repeated instances of mental harassment, favoritism, and discriminatory behavior, I urge you to ****demote him from his current position until his retirement****. His actions are not conducive to a healthy and inclusive school environment and are detrimental to the students, staff, and the institution as a whole.

3. Prevent Further Malice:

Ensure that Principals and other authorities in AEES are prevented from filing false allegations and engaging in acts of mental torture against staff members. Such behavior tarnishes the institution's reputation and creates a toxic workplace environment.

I remain committed to serving AECS-Turamdih and its students with dedication and sincerity. However, I seek your kind intervention to restore fairness and integrity within the institution and to protect my rights and dignity as an employee and a PWD belonging to a Scheduled Caste.

Additional Appeal:

I came across your contact information through the 'Department of Empowerment of persons with Disability under Ministry of Social Justice and Empowerment, Office order dated 15th July, 2024 appointed as "Nodal Public Grievances Officer". Recognizing your esteemed position and authority, I see you as my 'last resort' to save me from this catastrophic situation.

I sincerely request your intervention to uphold morale, protect my mental health, and restore a professionally healthy environment at AECS-Turamdih, Jharkhand.

I am confident that your timely and just actions will not only protect my rights but also bring integrity and fairness to the institution.

Subject: Grievance Regarding Repeated Intimidation and Threats against a PWD Staff Member (Myself, TGT-Art Teacher, the petitioner) by the Principal and Mr Saraj Dalai (TGT), AECS-Turamdih.

Dear Sir/Madam,

I am writing to bring to your attention the repeated instances of misconduct, intimidation, and threats I have faced as a Person with Disability (PWD) while serving as TGT (Art) at AECS-Turamdih. Despite previous grievances raised against similar incidents, the lack of action from the school authorities has emboldened such behaviour, putting my safety, dignity, and ability to work in a peaceful environment at risk.

Recent Incident:

On 21st November 2024, during the brunch break(10:30-11:00 am), while I was on my way to class, Mr. Saroj Dalai, TGT (Science), deliberately dashed into me in an unruly manner on the passageway. He then warned me in Hindi, saying, "If you come across me again, I will beat you up and give a tight slap on your face."

This threatening behaviour is not only an affront to my dignity but also a serious crime under laws protecting PWD individuals.

Despite raising oral complaints with the Principal (Mr Dnyaneshwar R Mohrir) and Vice-Principal (Mr Sunil Kanti Chakma) on the same day, no immediate action was taken. This lack of response reflects the institutional apathy towards addressing such grave issues.

Background and Previous Incidents:

This is not an isolated incident. I have previously faced similar misconduct and threats, which have been either ignored or handled inadequately by the school authorities:

Incident on 12th October 2022:

I lodged a grievance regarding Mr. Saroj Dalai's obstruction of my duties during the All India Inter-AEES Art Competition. Despite his repeated unprofessional behavior and humiliation, no action was taken against him.

Threats by Mr. Rajesh Kr. Bhatt (PHE Teacher):

On 29th April 2023 and 23rd June 2023, I raised complaints about Mr. Rajesh Bhatt's threatening behaviour, including an incident where he intimidated me with threats of harm outside the school gate. Despite the severity of the allegations, the matter was dismissed by the Principal, who absurdly stated that "since he hadn't done anything till now, there is nothing to worry about." Such a response from a person in a responsible position is not only irresponsible but also a blatant disregard for the safety of a PWD staff member.

Moreover, Mr. Rajesh Bhatt was later transferred to a location of his choice, further emboldening such individuals and discouraging victims from reporting misconduct.

Key Concerns:

Repeated Intimidation of a PWD Staff Member:

These incidents demonstrate a disturbing pattern of targeting and threatening a PWD staff member, which is a severe violation of my rights and safety.

Institutional Negligence:

The Principal (Mr Dnyaneshwar R Mohrir) and Vice-Principal (Mr Sunil Kanti Chakma) consistent failure to take these grievances seriously creates an environment where misconduct is tolerated and even encouraged.

Disregard for Legal Protections:

Threatening a PWD staff member with harm or obstructing their duties is a punishable offense under the law. The failure to act on such incidents undermines the legal framework meant to protect individuals like me.

Hostile Work Environment:

These repeated incidents have made it increasingly difficult for me to perform my duties in a safe and respectful environment, as expected in an institution under AEES.

Request for Immediate Action:

I request the following actions to address these concerns:

A Comprehensive Inquiry: A thorough investigation into the incidents involving Mr. Saroj Dalai and the previous cases involving Mr. Rajesh Kr Bhatt.

Strict Disciplinary Action: Appropriate and decisive action against individuals found guilty of misconduct, including Mr. Dalai and his accomplice Mr Principle-Turamdih

Ensuring Safety: Measures to guarantee the safety and dignity of PWD staff members, including me, at AECS-Turamdih.

Accountability of Authorities: An inquiry into the conduct of the Principal and Vice-Principal for their negligence in addressing these grievances and fostering a safe work environment.

The situation is further exacerbated by the biased and dismissive stance of the LMC Chairman at Jaduguda, the AEES Chairman, and the Secretary, who appear to favour the false allegations presented by the Principal without proper investigation. It is clear that the Principal's aim is to sabotage my image among committees and higher authorities, undermining my 14 years of contributions to the school's growth and betterment. His repeated efforts to discredit me indicate a personal vendetta to push me out of the system, preventing any progressive suggestions or ideas for the school's improvement.

It is also evident that the Principal has lost control over several facets of school regulation and facilities, yet his focus remains on tarnishing my reputation instead of addressing the pressing needs of the institution. This targeted harassment discourages not just me but any employee with genuine intentions to improve AEES and its students' futures.

I urge the appellate authorities and higher administration to conduct a fair and thorough investigation to uncover the truth and take appropriate measures to ensure justice. Only through such actions can the society truly reflect its commitment to integrity and the welfare of its staff and students.
